Tax Season is upon us and so is Tax Fraud!!

Tax Fraud. It is more than just a simple error in judgement. There are many kinds, all with penalties, and without proper advice and guidance, it's easy for a small matter to spiral out of control. Filing a false tax return or other document is treated seriously by the Internal Revenue Service. If its investigation turns up substantive information, civil cases can be referred for criminal tax investigation. Arrests and tax-related criminal charges could follow.

IRS Wants You to Know About Schemes, Scams and Cons

"If it sounds too good to be true, it probably is!" Don't become a victim to any scheme that offers instant wealth or exemption from your obligation as a United States citizen to file tax returns and/or pay taxes. Some of these schemes can literally cost you your life savings. Others can result in your prosecution and imprisonment if you knowingly participate in them.

Abusive Return Preparer

Taxpayers should be very careful when choosing a tax preparer. While most preparers provide excellent service to their clients, a few unscrupulous return preparers file false and fraudulent tax returns and ultimately defraud their clients. It is important to know that even if someone else prepares your return, you are ultimately responsible for all the information on the tax return.

Abusive Tax Schemes

Abusive tax scheme originally took the structure of fraudulent domestic and foreign trust arrangements. However, these schemes have evolved into sophisticated arrangements to give the appearance that taxpayers are not in control of their money. However, the taxpayers receive their funds through debit/credit cards or fictitious loans. These schemes often involve offshore banking and sometimes establish scam corporations or entities.

Nonfiler Enforcement

There have always been individuals who, for a variety of reasons, argue taxes are voluntary or illegal. The courts have repeatedly rejected their arguments as frivolous and routinely impose financial penalties for raising such frivolous arguments. Take the time to learn the truth about frivolous tax arguments.

When I was a boy there was always one thing that I enjoyed as much or more than anything else, and that was fishing!!! Growing up some of my family had a large pond in Stewartville on the Old Colman Road now called Coosa County Road 70. If you look on the map today, you can see the pond labeled Thomas Lake. During the summer I would go and visit my cousins and as soon as we could, my cousin and I would head over to the pond to see what we could catch. Most of the time it was small bluegill and the occasional catfish, but we didn't care. We loved to fish! As I grew older that desire continued. I remember when I was graduating high school I was going to work at Camp ASCCA, a camp for disabled children and adults. I had the opportunity to land my dream job as the fishing director. My friends told me that I would hate it due to the heat, but I just knew it was the perfect job for me. I was right. All summer I had the chance to take campers to the pond at camp and teach them how to fish, all day every day.

One day in particular I had a group of campers at the dock. Our groups usually consisted of 8-10 kids and their counselors. Most of the time was spent tying hooks and untying campers who had caught their counselor. Some of the kids would use a traditional rod and reel while others would use an old fashion cane pole. As I was baiting a kids hook, I heard the all too familiar cry "Help, I've got something." I didn't hurry too much because I just assumed it was one of the many bluegills that camp ASCCA's pond had. When I had the opportunity to turn around, I saw one of the campers, a 10-year-old boy with down syndrome, straddling a cane poll and the tip of the pole was bent down touching the water. As we battled the beast and finally got it in the net this young man had just caught a 7-pound catfish. I will never forget the look on his face as he stood there with pride admiring the fish that he had just caught.

My love for fishing has always given me a deep respect for the apostle Peter and Andrew when they were out fishing, and Jesus called to them and said, "Follow me and I will make you fishers of men." Scripture tells us that they dropped everything and followed Jesus. How amazing it must have been to watch them as their hearts were pulling them to leave everything that they knew and to follow the Christ. These men abandoned their livelihood and went to Jesus. They realized that without Jesus everything that they were doing was pointless. They devoted their lives to Him. As a response to their obedience, we see that Jesus kept his promise. In the book of Acts on the day of Pentecost Peter preached a sermon and 3000 people were saved.

INFORMATION YOU MUST BRING TO THE TAX SITE and required by the IRS.

- ✓ Last year's tax return
- ✓ Photo ID for taxpayer and spouse
- ✓ Social security cards for taxpayers and dependents
- ✓ W-2's; and 1099's B, R, and SSA.
- ✓ Employed taxpayers should bring a copy of their year-end pay stub.

In regards to the itemized deduction list, you should bring all the documentation that applies to you. Even if you do not itemize on your Federal taxes, you may be able to do so on your State return. **AFFORDABLE CARE ACT:** If you have health insurance through the government marketplace, bring your 1095-A which the government will send to you.

KELLYTON MAN ARRESTED FOR BURGLARY, THEFT

Last week a Kellyton man was arrested on burglary and theft related charges from a storage facility, with a second suspect being identified in the same case. Chief Deputy Scott Hammond reported that on February 13th the Sheriff's Office took a report for burglary and theft in the Kellyton area at Adding Space Storage. Investigators Middlebrooks, Ward and Hodge and Deputy Payton were involved in the follow-up investigation. They reviewed camera footage and observed that a vehicle was caught on camera, with the suspect seen in the vehicle entering the facility. After reviewing the video footage, law enforcement officers determined that they had seen the vehicle in Kellyton at another point in time. On February 23rd, Officers went to a Kellyton residence and identified the car outside the residence as being the one seen entering the storage facility. They proceeded to make contact with the individuals inside the residence and identified two suspects at that time. On February 23rd, a 31 year old Calvin Andrew Skinner of Kellyton was arrested and charged with 3rd Degree Burglary, 1st Degree Theft of Property and Possession of Burglary Tools. The other suspect in the case is still being investigated. Skinner's bond was set at \$20,000 for all three charges. As of press time, he remained in custody at The Coosa County Jail awaiting trial.


K9 Luca





The Yellow Dot Program

The "Yellow Dot" program is designed to assist Alabama citizens and first responders in the event of an automobile crash or other medical emergency involving the participant's vehicle. The program can help save lives during the critical "Golden Hour" by improving communication at a time when accident victims may be unable to communicate for themselves. Pick up a "Yellow Dot" folder here at the Sheriff's Office, have your photo taken and printed.

A "Yellow Dot" decal on the driver's side rear window of a vehicle alerts first responders to check in the glove compartment for the corresponding "Yellow Dot" folder. Having this information following a crash helps first responders positively identify the person, get in touch with family or emergency contacts and ensures that the person's current medications and pre-existing medical conditions are considered when treatment is administered for injuries.



Project Lifesaver

Project Lifesaver is a radio transmission system designed to assist law enforcement and rescue agencies in locating lost or missing persons who have been diagnosed with Alzheimer's, Autism, Dementia, or other disorders that may prohibit them from communicating personal information such as who they are or where they live. Project lifesaver can help provide peace of mind to caregivers. However, it does not replace the need for supervised care.

The transmitter is a small circular radio device on a wristband, approximately the size of a wristwatch. The transmitters and wristbands are worn 24 hours a day, 7 days a week and are difficult to remove without the appropriate tools. If the participant becomes lost or missing, the Sheriff's Office and emergency response services have specialized tracking equipment to help isolate the location of the transmitter the participant is wearing. The search will start from the last known location of the participant and work outward until the transmission signal is obtained. The goal is to determine the location of the signal in a quick, timely manner, minimizing the risk of harm to the loved one.

Neighborhood Watch Program

A citizen's involvement program where citizens, in cooperation with their local law enforcement agency, directly participate in the detection and prevention of crime.
